SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

3.2 POTENTIAL HEALTH EFFECTS

Eye Contact:

SECTION 4: FIRST AID MEASURES

4.1 FIRST AID PROCEDURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures

Evacuate unprotected and untrained personnel from hazard area. The spill should be cleaned up by qualified personnel.

6.2. Environmental precautions

For larger spills, cover drains and build dikes to prevent entry into sewer systems or bodies of water. Collect the resulting residue containing solution. Place in a metal container approved for transportation by appropriate authorities. Dispose of collected material as soon as possible.

Clean-up methods

Ventilate the area with fresh air. Read and follow safety precautions on the solvent label and MSDS.

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

Do not pierce or burn container, even after use. No smoking while handling this material. Do not spray near flames or sources of ignition. Avoid breathing of vapors, mists or spray. Aerosol container contains flammable gas under pressure. Avoid static discharge. Avoid eye contact with vapors, mists, or spray. Keep out of the reach of children. Avoid contact with oxidizing agents.
